Contract Agreement (Form PG3 -10)

THIS AGREEMENT made the 27th day of April, 2016 between **Director, Urban Development Directorate**, 82, Segunbagicha, Dhaka-1000 (hereinafter called “the Procuring Entity”) of the one part and **Managing Director, Global Brand (Pvt.) Ltd.**, 19/2, West Panthapath, (4 th Floor) Dhaka-1205. (hereinafter called “the Supplier”) of the other part:

WHEREAS the Procuring Entity invited Tenders for certain goods and related services, viz, **Lot-01:- Supply, Installation, Testing and Commissioning of Photogrammetry workstation and Software including intensive training for Preparation of Development Plan for Fourteen Upazilas Project** and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of **Taka 55,57,450.00 (Fifty Five Lac Fifty Seven Thousand Four Hundred Fifty Only)**. (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.

- (g) Drawings;
- (h) Price Schedules and Schedule of Requirements and;
- (i) other document including correspondences listed in the PCC forming part of the Contract

3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
