Contract Agreement

THIS AGREEMENT made the day of 29 May 2014 between **Director, Urban Development Directorate, 82 Segunbagicha, Dhaka-1000** (hereinafter called “the Procuring Entity”) of the one part and **Proprietor, Tamam Corporation, 27/11/3 C, Hasan Bhaban (2nd Floor), Topkhana Road, Dhaka-1000** (hereinafter called “the Supplier”) of the other part:
